Update on Efforts to Evaluate the HHCAHPS Survey Questions

- CMS is testing revisions to some of the HHCAHPS Survey questions! Current and near-future activities include:
 - Cognitive interviews the HHCAHPS Coordination Team has completed 9 interviews to-date (5 in Raleigh/Durham, NC and 4 in Chicago, IL). We will conduct 9 more in May 2019; and
 - Technical Expert Panel (TEP) review we are soliciting feedback on the results of the interviews and potential survey revisions from our TEP. The TEP includes home health agencies, patient advocates, policy analysts, clinical quality specialists, and hospital discharge planning staff.

What's New

- Revised Spanish surveys are available on the HHCAHPS website, under "Survey Materials."
- Reminder that the new supplemental questions data element should be submitted as part of the Patient Administrative Data Record. See <u>announcement</u> A.XML file templates on the website will be updated after the April 2019 data submission deadline.
 - <u>NOTE</u>: The "Consent to Share Responses" question <u>is</u> a supplemental question and should be counted for this new data element.
- The data submission tool will be unavailable briefly after the April 18, 2019 data submission deadline (for CY18,Q4 data) to make the XML file change noted above. We will notify vendors of this planned downtime via an email.

Use the table below to figure out if you need to submit a PER!
