Participation for Calendar Year (CY) 2023 HHCAHPS APU Begins Now!

- April 1, 2021, marks the start of the new CY2023 annual payment update (APU) participation period, which runs from April 1, 2021, through March 31, 2022.

Some Things We Learned from the 2021 Annual Vendor Update Training Session...

When asked what they enjoy most about working with client home health agencies, vendors reported....

"Helping them use the data to improve patient satisfaction"

"Hearing how the data are being used"

"Supporting them with answers to their questions"

"Hearing how we [vendors] can serve them better" "Doing short training sessions with new clients" "Reviewing survey results with them and talking about how COVID has impacted their patients"



90% of vendors reported no change in the number of agencies participating in HHCAHPS, despite the public reporting freeze in 2021.



82% of vendors reported that they would be likely to apply to administer a web option if CMS approves this mode.



61% of training attendees had looked at CMS' new Medicare Care Compare website.



85% of vendors have at least some staff working remotely due to COVID.
